10 – 11 September 2021

Programme

Celebrating the centenary of Rawls' birth and the jubilee of his major work, *A Theory of Justice*, we are paying homage to one of the most important philosophers of the 20th century, with remarkable contributions to political philosophy; a landmark for contemporary disputes over freedom, equality and justice setting at national level and in the society of nations.

Rawls' positions on the definition of the justice and on the international liberal order continue to generate notable appreciation and harsh criticism. They are the best proof of the value of his ideas and their potential to be applied. The contributions to this colloquium are part in this lively exchange of ideas.

The colloquium is organized online for two days: September 10th (Friday) and September 11th (Saturday); its first section will be conducted in English, the others in Romanian. The presentations should take about 20 minutes followed by 10 minutes for discussions.
